REFERENCE **REACH Statement**

Dear Sir or Madam!

We would like to inform you about the REACH activities of voestalpine Böhler Bleche GmbH & Co KG.

The REACH-Regulation EC (No) 1907/2006 regarding Registration, Evaluation, Authorisation and Restriction of Chemicals was put into force in June 2007. This regulation includes all substances produced or imported from outside the EU above one ton per year regardless of their hazardousness. As REACH is a regulation it doesn't need national implementation but is legally applicable to all countries in the European community.

Substances, preparations and articles from other producers are used in the manufacture of our products. As a result voestalpine Böhler Bleche GmbH & Co KG stays in close contact with its suppliers in order to ensure that both our applications and that of our customers are taken into consideration in the registration dossier of the suppliers.

Brief and general information pertaining to the application of our substances will be registered to the extent that such application of a given substance is not discouraged. For the purpose of creating a complete registration dossier, general application and exposure categories will be created by the whole steelmaking industry. Within the dossier all applications of the downstream users will be considered.

We ensure that due to the REACH regulation there won't be any changes or limitations concerning the availability and quality of our products and deliveries.
